## RE: <u>HUD Dual Certified Gas & Electric Models For Modular Construction</u>

Please be advised that the Rheem HUD Certified gas and electric water heaters listed below are dual certified for both HUD mobile home and modular construction provided the water heater is installed in accordance with the Installation Instructions supplied with the water heater and complies with the provisions of national or regional residential construction codes that may govern water heater installations in modular residential construction, local codes or in the absence of local codes, the latest edition of the National Fuel Gas Code, ANSI Z223.1. The following HUD Certified water heater models are designed to meet or exceed ANSI requirements and/or UL and have been tested according to D.O.E. test procedures and meet or exceed the energy efficiency requirements of NAECA II, ASHRAE Standard 90, BOCA Code and all state energy efficiency performance criteria for energy consuming appliances.

- > 72 Series Electric Side Connect All single and double element electric models with one or five year limited warranty (20 through 50 gallon):
  - o **One Year**: 72-20-1, 72-30-1, 72-30-2, 72-40-1, 72-40-2, 72-52-1, 72-52-2

- <u>82 Series Electric Top Connect</u> All single and double element models with one or six year limited warranty (all tank sizes)
  - o One Year: 82-30-1, 82-30-2, 82-40-1, 82-40-2, 82-52-1, 82-52-2
  - Six Year: 82V30-1, 82V30-2, 82V40-1, 82V40-2, 82V52-1, 82V52-2, 82V66-2, 82V80-2, 82V120-2, 83VR40-2, 83VR52-2, 83VR66-2, 83VR80-2
- <u>83 Series High Efficiency Electric Top Connect</u> All models with six year limited warranty (all tank sizes)
  - o **Six Year**: 83VR40-2, 83VR52-2, 83VR66-2, 83VR80-2
- ➤ 21IRDV Series Gas Direct Vent Side Connect Direct Vent gas models with one or five year limited warranty produced after February 1, 2004 (check 1<sup>st</sup> four digits of the serial number for production month & year) are dual certified to meet HUD and modular code installation requirements, provided fresh combustion air from outside the home is provided to water heater installations located over a basement or un-vented crawlspace per UL307b, Section 4.3(c). The

Rheem PreferredVent™ Side Air Inlet Kit (AP12191-2) is recommended for basement & un-vented crawlspace installations (30, 40 & 50 gallon) in both HUD and modular construction.

- > <u>22DVX Series Gas Coaxial Direct Vent Top Connect</u> All Coaxial Direct Vent gas models with a one or five year limited warranty (40 & 50 gallon).
  - o **One Year**: 22I40SDVX, 22I50DVX
  - o Five Year: 22V40SDVX, 22V50DVX
